Council Meeting was called to order at 4:30 P.M. by Mayor Hendrickson.

Roll Call Roll Call of Councilmembers showed the following members present: Hubbard, Larson, Kunz, Thomas.

Councilmember Hubbard declared a conflict of interest with the business license for Kevin Hubbard (Hub's Performance Shop), and with the Oneida Academy Celebration proposal.

Item Added To Agenda

Mayor Hendrickson proposed an item be added to the agenda. It was moved by Councilmember Larson and seconded by Councilmember Hubbard to schedule a Public Hearing before the Planning & Zoning Commission to update the Preston City Municipal Code to allow existing homes within the Business zones to be improved, added to, upgraded or remodeled, and prohibiting the construction of new homes within the Business zones. This was added because information regarding this item was received after the agenda was posted. This received unanimous approval.

Wine License

Teri Christensen (Wellcome Mart)

It was moved by Councilmember Hubbard and seconded by Councilmember Larson to approve the above wine license. This received unanimous approval.

Restroom Proposal At City Park

Wes Harris, of the Franklin County Fair Board, proposed demolishing the existing restrooms on the Fairgrounds at the City Park and rebuilding larger restrooms at the same location. He explained that to qualify for a grant, the City's help would be needed with water and sewer lines. After Council discussion, the Council voiced their support for the project and requested a defined plan.

Oneida Academy Celebration Proposal

Saundra Hubbard, as a private citizen and representative of the Oneida Stake Academy, introduced plans for an Annual Franklin County Heritage Day to be held each year on July $24^{\rm th}$. She explained that the Oneida Stake Academy plans to hold heritage centered activities, a dinner and a dance once a year to celebrate our heritage.

Euthanasia Training For Animal Control Officer It was moved by Councilmember Larson and seconded by Councilmember Thomas to approve a request to send Animal Control Officer Heath Edwards to classes in Pocatello, Idaho, certifying him to provide euthanasia services and chemical capture. This received unanimous approval.

Contract With City Engineer It was moved by Councilmember Hubbard and seconded by Councilmember Larson to approve a Professional Services Contract between the City of Preston and JUB Engineers, Inc. for city engineering services through September 30, 2013. This received unanimous approval.

Business Zone Ordinance Changes It was moved by Councilmember Larson and seconded by Councilmember Thomas to schedule a Public Hearing before the Planning & Zoning Commission on February 13, 2013, to consider amending the Preston Municipal Code to further define restricted residential uses in the Business Zone, deleting group child care as a permitted use, clarifying height setback and lot coverage restrictions, prohibiting new residential construction and enlargement of existing two-family, three-family and multi-family dwellings. This received unanimous approval.

Executive Session It was moved by Councilmember Larson and seconded by Councilmember Hubbard to enter Executive Session to discuss personnel as allowed by Idaho Code 67-2345(1) (b). The vote was as follows:
