He discussed the creation of two additional residential zones; Residential O, which would take homes within the designated zoning area and bring them into conformity and encourage the development of remaining vacant parcels; and Residential A, which would reserve residential neighborhoods and encourage the development of medium density areas best suited for moderate income individuals.
FEE IN LIEU OF PARK SPACE	City Engineer Mark Owens informed the Board that the amendment to the open space ordinance, providing alternative means to satisfy open space by voluntary contribution of land or funds to the city, had been scheduled for public hearing.
