REVIEW & APPROVE P&Z **MINUTES** 8/12/2020

It was moved by Commissioner Fred Titensor and seconded by Commissioner Berni Winn to approve the Planning and Zoning Minutes of October 14, 2020 as written.

The vote was unanimous in favor.

COMPRE -HENSIVE PLAN AND **ZONING** DISCUSSION The commissioners, along with Shawn Oliverson, Economic Development Director, read through a draft of the accessory dwelling unit overlay and discussed any changes or concerns that came up. Mr. Oliverson indicated that he and City Attorney Preston Rutter would meet the next day to discuss definitions to add some clarity. The commissioners discussed the requirement for an inspection to ensure habitability, changing the utility hookup restriction to city services only, and the minimum lot size and lot coverage for an accessory unit.

Commissioner Titensor stated that they have four major sections of the comprehensive plan to discuss with city council and that he would like to see those changes get put into place as quickly as possible. The commissioners discussed the possibility of taking their drafts to the city council for review.

Commissioner Titensor moved to take the drafts of ordinances for downtown parking, animal rights, multi-family housing, and accessory dwelling units to the city council for review. Commissioner Cole seconded the motion.

The vote was unanimous in favor.
